Sub:- Amount of Dearness Allowance to the employees of RSGSM Ltd.

- (1) The Director Incharge is pleased to order that the existing rates of Dearness Allowance, payable to the employees of RSGSM Ltd. shall be revised from 125% to 132% w.e.f. 1st July, 2016 with reference to Finance Department Order No. F.6(1)FD(Rules)/2008 dated 17.11.2016.

(iii) Cash payment shall be admissible (employees of RSGSM and officers on deputation from State Government) in the Salary From the month of November 2016.
