3. The E.N.A. (Grain Based) IS-6613-2002 to be supplied should conform to IS specification No. 6613-2002 (as amended from time to time). It should be fit for potable use and the strength of E.N.A. (Grain Based) IS-6613-2002 shall be minimum 68.24° OP. Certificate issued by Excise Official of Exporting State to this effect as well as showing that the ENA (Grain Based) IS-6613-2002 conforming to IS-6613:2002 and fit for human consumption shall be furnished with each consignment as per annexure "A" attached with this document.
4. **ACCIDENTAL LOSSES:** In case of any loss is faced by RSGSM due to accident of tanker and non-supply of ENA thereof then bidder shall be responsible for such loss and shall have to compensate it.
5. **INSURANCE:** Insurance of material in transit shall be arranged by the bidder at their own cost.
6. **Supply Schedule:** Supply Permits will be got available to the successful bidder time to time in phased manner on fortnightly/monthly basis and successful bidder shall have to strictly adhered to.
