**2. Financial bid will be opened only those bidders who have qualified both criteria's mentioned as below :-**

- A) Technical Test approval - As per approval of samples by lab.
- B) Sensory Test approval – By committee - The sensory test will be carried out by the panel of Liquor experts (as deputed/ nominated by RSGSM/RC Jhotwara). The expected Dosing of essences be recorded first and committee can visit such distillers where firm has already supplied.

Imbibers experts – tentatively may be as follows: -

- 1. Whisky Imbiber Group Members
- 2. Defense Personnel's
- 3. Any Retired Officers
- 4. Any person of repute with knowledge of liquor testing.

The sensory test will be based on following (Annexure-J ) : -

- 1. Appearance

**3. The bidder has to provide following information with the technical bid :-**

- A) For Essence: Provide the list of prominent distillers/bottlers where the firm has supplied; with list of brands, and of which these distilleries are manufacturing and using for Rum, Whisky, Gin & Vodka. (provide document with proof)
- B) Caramel Color : 1. Provide the list of prominent Distillers/bottlers, where supplied for production of alcoholic beverages; 2. Shelf life for caramel color when used in Rum / Whisky.(provide document with proof)

**4. The supplier of essence should depute a Blender for dosing of their essence, at Jhotwara RC, where in starting month training be imparted and will check bi-monthly and give report for any complaints or market acceptability.**

**5. Action at Laboratory ( Jhotwara ) level:-**

The caramel color samples, be kept for a period till shelf life mentioned. The sample of blends of whisky/Rum be kept in Lab and shelf life be checked, for which suppliers signatures and other record be prepared (in the presence of supplier) and if color fades within shelf life, action will be taken against the supplier firm.

**6. Bid security:** Total estimated cost, based on total bid quantity, has been calculated ₹ 496.48 lakhs (including GST), on the basis of which bid security @ 2% i.e. ₹ 9.93 lakh should be submitted by the bidder. Bidders interested in part items of NIB then such bidder shall have to submit bid security @ 2% of value of bid quantity as per special condition no. 1(c).

**7. The supplier shall have to ensure proper quality of supplied subject matter of procurements per specification. In case of testing of sample, subject matter of procurement found below specifications then whole quantity of supply / consignment shall be rejected. In such case RSGSM will procure the subject matter of procurement up to or higher to the specifications from open market at the risk and cost of the bidder.**

**8. Payment:** 100% payment shall be made from head office on receipt of bill duly verified from the in charge of respective reduction center along with dispatched note, receipt note quantity and test report of lab.

**9. The bidder shall have to strictly adhere to supply schedule. In case of failure in maintaining supply as per schedule, quantity received lesser side may be procured from any source / market on the risk and cost of the bidder.**

10. The bidder will have to make supply at reduction center i.e. various reduction centers of RSGSM as per annexure 'H'. The bidder shall ensure commencement of supplies within 5 days from date of issue of order.
11. **Variation in quantity:** Variation up to  $\pm 1\%$  shall be allowed in total quantity to be supplied for the purpose of completion of the supply order.
12. The procuring entity reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the bidders.
13. If the procuring entity does not procure any subject matter of procurement or procures less than the quantity specified in the bidding documents due to change in circumstances, the bidder shall not be entitled for any claim.
14. Any duty, taxes etc. Paid at the time of purchase shall be refunded to us in the event of the sum being held to be not payable.
15. Management reserves the right to reject the bid of such bidders whose performance is found unsatisfactory during the period of contract. Similarly, if any bidder is found / declared black-listed at any time during contract period then the contract will immediately be terminated.
16. If any manufacturer/ authorized dealer is found involved in manufacturing/ trading of illicit subject matter of procurement then RSGSM will lodge FIR against him and such bidder shall have to face legal consequences.
17. **Rate:-** Single rate F.O.R. at godown / warehouse of reduction center should be quoted in financial bid (online). GST shall be shown separately ,If GST will not be shown separately, the quoted rate shall be assumed inclusive GST.
18. **Evaluation:-** The bids will be technically and financially evaluated.
19. **Period:-**The period of rate contract shall be two years, the existing rate contracts may be extended on same price, terms and conditions as per RTPP Act 2012 and Rules, 2013.
20. **Recovery:-** 10% of value of total unsupplied quantity + 18% GST thereon shall be recovered from bidder as penalty for unsupplied quantity against supply schedules.
21. If any supplier fails to supply as per given supply schedule during contract period without any satisfactory reason, then work performance security amount will be forfeited with 18% GST and agreement will be terminated with immediate effect.
22. The bidder shall have to offer 100 % quantity of total bid quantity of the item for which bidder is submitting the bid.
23. No counter condition shall be accepted.
24. **Inspection of factory/ works of the bidder:** The RSGSM ltd. will be free to carry out sudden inspection of the factory/ works of the bidder before or during the supply contract without prior intimation. - i. The sample of subject matter of procurement from every consignment will be got tested from the RSGSM laboratory, Jhotwara, Jaipur /Government authorized laboratory or any reputed private laboratory for all the parameters as specified in bid and contract. If supplier's representative is not available within three days on receipt of consignment, the company shall have right to draw the necessary sample and get it tested. In this case the supplier shall not claim any benefit, on ground of the absence. The testing fee paid shall be borne by the company. In case of rejection of article found sub-standard on testing, the testing fee so paid will be recovered from the supplier.
  - ii. The company may get tested the sample of subject matter of procurement from any reputed laboratory accredited from NABL (National Accreditation Board for Testing and Calibration Laboratories).

27. **Breakage/defects:** - Transit breakage/ cost of defective goods shall be borne by supplier which shall be detect during the process of filling and no payment of such defective material shall be made to the bidder.
28. Date of receipt of material at the destination shall be considered for calculating recovery of liquidated damages.
29. The supply schedule for quantities shall be given from time to time as per requirement.
30. Every bidder shall have to submit registration certificate stating the manufacturing of subject matter of procurement issued by industries department/MSME, Rajasthan so as to justify the status of MSME unit for availing the benefit of bid security at reduced rate @ 0.5% of the estimated value of the offered maximum quantity.

## **GENERAL TERMS & CONDITIONS**

1. The bidder shall have to carefully study and understand the conditions, specifications, size, make etc. of the goods to be supplied. If it has any doubt about the meaning of any term, condition or specifications etc. he should refer to officer in charge and get clarification. The decision of the company regarding interpretation of the conditions and specifications shall be final and binding on the bidders.
2. Bidders are hereby explicitly warned that individuals signing the bid must specify as follows :-
  - a. Whether signing as "sole proprietor of the firm?"

- (b) The maximum amount of liquidated damages shall be 10%.
  - (c) When the successful bidder is unable to complete the order/contract within the specified or extended period, the company shall be entitled to accept supply from the open market without giving any notice to the bidder but at his risk and cost i.e. bidder's account and risk the goods or any part thereof which the bidder has failed to supply or if not available the best and nearest available substitute thereof or to cancel the contract and the bidder shall be liable for any loss or damage which the company sustained by reason of such failure on the part of the bidder. ### **(1) Filing an appeal**

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it of within thirty days from the date of the appeal.
- (3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

### **(4) Appeal not to lie in certain cases**

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) determination of need of procurement;
- (b) provisions limiting participation of Bidders in the Bid process;
- (c) the decision of whether or not to enter into negotiations;
- (d) cancellation of a procurement process;
- (e) applicability of the provisions of confidentiality.

### **(5) Form of Appeal**

- (a) An appeal under para (1) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.

- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorised representative.

**(6) Fee for filing appeal**

- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.

## Annexure D

### Additional Conditions of Contract

#### 1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

#### 2. Procuring Entity's Right to Vary Quantities

- i. If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.
